



This major conference was attended by over 300 religious and academic figures from more than 70 countries. This issue of the periodical also contains the sixteenth issue of the peer-reviewed journal "Religions," entitled "Physical and Spiritual Well-being: Religious Perspectives". It is published in conjunction with the World Cup FIFA Qatar 2022, the first-ever World Cup in the Middle East.

We also read news about DICID's local seminars, including a symposium (The Role of Interfaith Dialogue in Building Trust among Multicultural Societies) organized in collaboration with the Embassy of the United States of America in Qatar and the Katara Public Diplomacy Center. She heads several national and international organizations and associations and is a member of numerous national and international organizations and associations.

Prof. Aisha has received several awards including the Award of Excellence for the Arabian Gulf from H.H. Shaykh Tamim Bin Hamad, 2015, the Henry Davison _ Award International Association of the Red Cross and the Red Crescent, Switzerland 2015, the Arab Women Award from the Arab League, 2014, the Community Service Award - Ajman, United Arab Emirates, 2011, the Award for Personage of Peace and Proximity from the Islamic Republic of Iran, 2011, the Medal of Honor for Arts and Sciences of the First Level from the Arab Republic of Egypt, 2007.

Prof. Dr. Aisha is the author of several articles and books on theology, tasawwuf and religions, including Introduction to the Creed and Religions, Foundations of the Creed between Shia Imamate and Mu'tazilites, Islamic Mysticism and Morality, Abu-Haf's Omar Al-Suhrawardi: His Life and Mysticism, Muslim Women and the Renaissance, Al-Takleef bi ma la Yutaq [The Prescription of the Intolerable According Muslim Theologians], Shavkh to Muhammad al-Ghazali's Methodology of Religious Discourse, and many others to mention.

When she was asked about her experience as Vice Chairman of the Board of the International Center for Interfaith Dialogue, and her view on the importance of dialogue in general and religious dialogue in particular, she replied, "There is no doubt that dialogue is of utmost importance at any time and

in any place until the hour strikes. Dialogue is the only and optimal solution to all human problems. God Almighty has endowed human beings with reason, logic and thought, but He has not preserved and protected them from errors and mistakes in thought and opinion.

The wisdom of God Almighty has made it necessary to place man on the list of hierarchies in His creation of all creatures, and God Almighty has subjected to him the universe with all that is in it, and has distinguished him with ability, reason, and will, and has assigned to him rights and duties, and has made him the representative of the earth, as the Almighty said: In it ([Hud: 61], "He has created you from earth and made you settle therein", and not only that, but the Almighty also sent him messengers and prophets who delivered to him the teachings of God Almighty and his messages, showed him the way so that he would not go astray, and explained to him what was hidden from him and made man accountable and responsible. The Almighty said, "I did not create jinn and humans except to worship Me": 51: 56. "O mankind! We created you from a single (pair) of a male and a female, and made you into nations and tribes so that you may know each other (and not so that you may despise each other). Verily, the most honoured of you in the sight of Allah is (he who is) the most righteous of you. And Allah has full knowledge and is well acquainted". 49:13. The Prophet (ﷺ) said, "All of you are guardians and are responsible for your subjects" (Bukhari and Muslim), and he, peace and blessings of Allah be upon him, said, "O people, your Lord is One, and your father is One, you are all descended from Adam, and he was made



of clay." Narrated by Imam Ahmad.

These teachings were delivered by all prophets and messengers and confirmed by the noble Quran in obedience to all prophets: "The Messenger has believed in what has been revealed to him from his Lord, and the believers as well. All have believed in Allah, and His angels and His Books, and His Messengers. "We make no division between any of His Messengers,"". 2: 285.

Prof. Dr. Aisha also added: "One of the most important features of modernity and postmodernity is the issue of "Interfaith Dialogue" and similar terms and concepts. There are a number of objective reasons for this, the most important of which are:

- 1- The topics of scientific research arise from community needs and local, regional or global problems. Interfaith dialogue has proven its worth.
- 2- The age of technology and the resulting speed of communication, the reality of globalization and the participation of

people in the common life events require the need to understand the other and demand the reality of living together. This is done through dialogue and communication.

3- The fact that some groups have emerged that play a role in spreading terror and destabilizing security and stability in some areas is another factor that promotes, connects and intensifies efforts to create a culture of dialogue and coexistence. It is known that Doha International Center for Interfaith Dialogue is responsible for studying issues of interfaith dialogue from a religious and cultural perspective with a sober and scientific approach, as it is the official institution and center in Oatar that promotes peaceful coexistence between followers of religions and different nationalities and is a world reference in the field of interfaith dialogue. And the consolidation of a culture of coexistence.



14th Doha Interfaith Conference



Doha International Center for Interfaith Dialogue, in cooperation with the Permanent Committee for Organizing Conferences at the Ministry of Foreign Affairs, organizes The 14th Doha Conference for Interfaith Dialogue:

"Religions and Hate Speech: Between Scripture and Practice"

(24-25) May 2022

Under the patronage of His Excellency, **Sheikh Khalid bin Khalifa bin Abdulaziz Al Thani**, Prime Minister and Minister of Interior; Doha International Center for Interfaith Dialogue conducted in the capital city of Qatar Doha on May 24 – 25, 2022 the 14th Doha Interfaith Conference 2022 activities under the title: "**Religions and Hate Speech... Scriptures, and Practice**", which was attended by elites, great personalities, intellectuals, decision-makers, thinkers and researchers of the scholars of the three monotheistic religions (Islam, Christianity, and Judaism) from all over the world. The total number of participants from abroad was 263 contributors from 78 countries, in addition to the participants from the State of Qatar.



At the beginning of the conference in the opening session H.E. Mr. Soltan bin Saad Al-Muraikhi State Minister for Foreign Affairs delivered an opening speech and welcomed the audience. He praised the title of the conference, appreciated the diversity of the selected topics, and commended the Scientific conditions set up for accepting contributions. His Excellency stressed that combating hate speech is a serious issue that requires tremendous cooperation to achieve the goals of the interfaith dialogue bodies through relevant contributions at the conference, in-depth studies and analyses, and effective discussions among the leaders of the major world religions as well as researchers and intellectuals.

In a statement, about the conference, **His Excellency Prof. Ibrahim bin Saleh Al Naimi**, Chairman of the Board of Directors of Doha International Center for Interfaith Dialogue said: "The conference was scheduled for March 3 - 4, 2020, but, was postponed due to the conditions of the coronavirus pandemic, and the compromised safety of participants." He added: "This annual conference is held periodically and is attended by more than 300 personalities from about 70 countries, in addition to participants from the State of Qatar. This conference is the regular academic and discursive forum between thinkers and representatives of the three monotheistic religions (Islam, Christianity, and Judaism), a select group of religious scholars, academics, and leaders of centers of interfaith dialogue from around the world". He made it clear that hate speech is a violation and undermining of human rights which are among the most important religious and humanitarian issues of today that need to be highlighted and emphasized. Therefore, the aim of this conference is to discuss the problem of hate speech and its dimensions as well as the positions of religions against it and to call for respect, tolerance, and compassion. The conference will be attended by religious scholars, former civil servants, academics, heads of institutions, college professors, college students, charitable institutions, and civil society organizations, as well as representatives of the countries most affected by hate speech.

After the opening session, two days of discussions took place in three plenary sessions, nine parallel sessions, and one closing session. In these sessions, participants gave presentations on their respective topics. The audience commented that many good papers were presented and that the presentations showed good practical activities and experiences.

His Excellency Prof. Ibrahim bin Saleh Al Naimi, Chairman of the Board of Directors of





Doha International Center for Interfaith Dialogue pointed out that Doha International Center for Interfaith Dialogue has become a source of pride for every Qatari citizen and every Arab and Muslim. He noted that the inclusion of this type of topics for dialogue with followers of other religions "reflects the progress we have achieved in thinking and civilizational philosophy, and that the State of Qatar, which is represented in Doha International for Interfaith Dialogue, believes that nation building begins with nation building and that this nation building is done through cooperation with fellow human beings on the basis of mutual respect, coexistence in harmony and peace, regardless of the different religions, cultures and races. The Center is the leading institution in Qatar engaged in interfaith and intercultural dialogue, capacity building in the field of dialogue, and working for a culture of peace.

In his statement, His Excellency praised the initiatives of the State of Qatar in the field of dialogue and consultation between the followers of these religions, as well as Qatar's positive role in issues of dialogue between civilizations and cultures, which has brought Qatar a prominent global position and made it one of the most influential countries in the world in these issues. He added that Qatar, with its wise leadership, is at the forefront of addressing such important issues. It is a country that is always in search of peace and harmony and has many notable contributions and roles to its name.

He added that the continuation of this dialogue in the state of Qatar enriches the pioneering role it plays in this field, especially as it is a multicultural country where many nationalities live, visit or participate in conferences or events it organizes, making the interfaith conferences in Doha another addition to these human dimensions.

When he was asked how the fruits of the dialogue can be transferred from the class of religious scholars and thinkers to the general public, His Excellency Prof. Ibrahim bin Saleh Al-Naimi replied: "Although the conference deals with leading figures and thinkers, its fruits have already migrated from the top-down, embodied in activities, research, conferences, and more. The conference is also attended by many students from universities and colleges in the country, we call on college students to participate in such important conferences."

He emphasized that: "Among the objectives of the conference is to convey to the interlocutors



the point of view of Qatari citizens and Muslims on the issues raised and to clarify an Arab-Islamic vision of Qatar without compromising on principles or loyalty at the expense of religion, as well as to explain the principles of Islam and its call for tolerance, respect and life. And rejecting hatred and aggression against non-aggressors."

He said, "The world in which we all live today is threatened by two fundamental dangers. The first is terrorism, which we all want to fight together, and the second, which is no less dangerous than its predecessor, is the escalation of hate speech in all its forms and its exclusionary and racist forms that classify people based on their religion, gender, or skin color."

Dr. Al-Naimi also elaborated on the commonalities of the monotheistic religions, stressing that all religious texts in the heavenly books call to fight hatred and spread respect and tolerance, but he saw that the practice on the ground shows the opposite, where hatred is practiced in the name of religion. And before that, religions became a means to fight other religions, and hate speech was the first means to do so.

He pointed out that "the conflicts facing the world today, in which religious intolerance plays the greatest role, in which the misunderstanding of the true purposes of religion prevails, and the support of this understanding with an authoritarian view and practices borne of religious and national hatred, as well as the claim to guardianship over the mind, have emerged from extremist models based on misconceptions, prejudices, and false mental perceptions fueled by hate speech that contradict the idea of dialogue and peaceful coexistence, thus fanning the flames of conflict between civilizations.

He also pointed out that Doha International Center for Interfaith Dialogue has called more than once, in its conferences and on many occasions, to develop a strategy to counter the religious, legal, and moral threat of hate speech, that is increasing around us and intensifying its negative effects; The Center believes that there is no other way to confront this discourse than to confront its origin and purify its roots, by dialogue with thought, and trying every way to expose the misdirection inherent in calls for sectarianism and racism and rejection of the Other.





Conference sessions

Prof. Al-Naimi also pointed out that the speakers and participants of the conference focused on the commonalities and called for a common word between the monotheistic religions in order to find a basis for coexistence for the benefit of humanity in general, away from discussing the ideological issues of each religion. He added, "Respect for the origins of other religions requires us to respect them now, and we invite them to a dialogue that positively reflects the reality of the followers of different religions inside and outside their countries. It is expected that the results of this dialogue will lead to a decrease in hatred between the followers of these religions, especially hatred of Islam and Muslims and what has become known as Islamophobia or the unjustified fear of Islam and Muslims that plagues the Ummah in non-Muslim countries. Addressing these problems are the goals we strive for and have already achieved.

Regarding the issues discussed at the conference,

His Excellency Dr. Ibrahim bin Saleh Al Naimi noted that three axes are discussed: The first deals with hate speech in terms of causes, motives and risks. In this context, he said, the extremist religious discourse and its role in the spread of hate speech, the concept of hate speech and the misunderstanding of religion and the promotion of moderate discourse is addressed, in addition to the issue of escalation and spread of hate speech and the extremist discourse of some clerics and political leaders and its impact on achieving world peace.

He indicated that the second focus, entitled "Patterns and Forms of Hate Speech", focused on the danger of spreading hate speech, hate speech and incitement to violence and terrorism, the political uses of hate speech, and the effects of spreading hate speech and its effects on peaceful coexistence. It also addressed the practices of hate speech and their effects, the rise of racism due to hate speech, the escalation of hate speech against refugees and religious



minorities, hate speech and discrimination against women.

Dr. Al-Naimi stated that the third focus-of the conference is titled "The Desired Role to Confront Hate Speech" and will address the role of religious and media leaders and institutions in combating hate speech, the responsibility of religious scholars and houses of worship in raising awareness of the need to respect religions, the influence of the media in curbing hate speech, religious and moral values and their role in combating hate speech, and a culture of peace, coexistence and respect for cultural and religious diversity.

He explained that under the third axis, participants will also discuss the issue of international laws and conventions criminalizing hate speech, clarifying the limits of the application of freedom of expression and the protection of international humanitarian law, and spoke about international conventions and dealing with hate speech, religious and legal frameworks in the face of hate speech, the role of education and educational institutions in dealing with hate speech, discussion on the importance of educating younger generations in dealing with hate speech, dealing with hate speech through culture and the arts, and the need to respect diversity and to accept and understand the other.

Fourth Doha International Award for Interfaith Dialogue

During the opening ceremony of the conference, the fourth Doha International Award for Interfaith Dialogue was presented. The title and theme of the award were chosen in line with the objectives of this year's conference:

'Outstanding Contributions to Spreading the Culture of Moderate Discourse'. Award winners are selected based on their achievements in spreading the culture of moderate discourse, bringing together people and followers of different religions, and rejecting hate speech, incitement, discrimination, racism, extremism and terrorism. The award is overseen by a special board of trustees composed of Muslim, Christian, and Jewish scholars, as well as Center staff. The Board of Trustees selects reviewers from among the best experts from around the world to serve as reviewers. Doha International Award for Interfaith Dialogue was launched in 2013 and is a unique initiative of its kind in the field of interfaith dialogue worldwide

Three individuals and three institutions were selected to receive the award.

The individuals who received the award are: A.D. Mohamed Khalifa Hassan Ahmed -Egyptian in Qatar, Dr. Sabrina Lee - Italy, and Rev. Dr. Malkhaz Songelashvili - Georgia.

As for the institutions, they won: Islamic Culture Foundation - Spain, Wolf Foundation - United Kingdom, and Side by Side Foundation for Antiracism - Germany.

Our esteemed authors have enriched the issue with informative articles characterized by in-depth analysis and a solid knowledge base.

2- Periodical Newsletter, Issue 15:

Doha International Center for Interfaith Dialogue has released its 15th issue of Periodical Newsletter to its esteemed readers and writers, in conjunction with the final preparations for the fourteenth annual DICID International Conference entitled: "Hate Speech: Scriptures and Realities," held in Doha, Qatar, on May 24 -25, 2022. The issue has also highlighted the international seminar titled: "Escalation of Hate Speech among Minorities in the West".

3- "Selected Papers":

Doha International Center for Interfaith Dialogue has published two selected letters in Arabic and English, "Religions and Hate Speech: Causes, Types, and Ways to Confront. The Arabic paper was edited by Dr. Ahmed Abdel Rahim, while the English paper was edited by Dr. Sinad Marharovic, under the same title.

Conference Closing Remarks

In light of the paper presented and the discussion that took place, we would like to briefly address some of the key points that were highlighted during the deliberations. These concluding remarks include the findings and recommendations that the conference concluded; they are as follows:

First, to affirm that all religions call for respect and peace and that they condemn all forms of hate speech, extremism, racism, and discrimination based on religion, gender, or race.

Second, to emphasize that confronting extraterrestrial thought and action is a human



duty and a noble work. We will work together to combat terrorism and extremism at the level of individuals, institutions, religious leaders, and political and civil societies in order to establish human ethics, spread peace and love, and build a civilized world.

Third: Condemnation of all forms and types of hate speech and rejection of behaviors and practices of extremist groups that call themselves religion, while the essence of religion is far removed from their deeds and actions.

Fourth: The need to use all legal means to develop an ethical strategy for the media on a professional basis. The goal is to limit the spread of hate speech on social media in the name of freedom of expression and to enforce compliance with the law on these platforms.

Fifth: The need to develop, adopt and submit a proposal to international organizations to develop curricula (especially for early childhood education) that teach the correct and proper religious principles and values that call for respect and coexistence and eradicate anything that inspires and incites hatred. And urge religious leaders to implement this proposal in their respective countries in accordance with the teachings of their religions.

Sixth: Ensuring that there are no forms of double standard discourse among those involved in interfaith dialogue; there should be no internal discourse that supports, incites, and calls for hatred, while external discourse publicly condemns hatred in the presence of people.

Seventh: Stressing that the phenomenon of Islamophobia and prejudice against Islam is not the method of the majority in the West, but is practiced by minorities who ignore the true teachings of Islam and its essence, and are not familiar with the history of Islam and its civilization of tolerance, pluralism, and acceptance of others.

Eight: Emphasizing the transition from this phase of interfaith dialog to a phase of genuine partnership and interaction between the institutions of religions as well as civil societies; a single voice condemning hate speech regardless of its sources and originators.

Nine: Communication with effective and influential interfaith dialogue bodies worldwide about the need to unite efforts in support of oppressed people suffering from hate speech and genocide, as is happening in Kashmir, the Rohingya minority, and the Uyghurs, and to openly reject all forms of hatred and oppression whenever and wherever it occurs, regardless of race or religion.

On the occasion of 50 years of diplomatic relations between the State of Qatar and the United States of America and among intellectual and cultural activities conducted by Doha International Center for Interfaith Dialogue for promoting the notion of coexistence and creating awareness among people, and as part of maintaining theeffective cultural role Katara isknown for, for being Qatari pivot to present its cultural, civilizational and intellectual heritageof the state of Qatar, as well as aiming to achieve the common objectives of the organizing parties; Doha International Center for Interfaith Dialogue, in cooperation with the Embassy of the United States of America, and Katara Public Diplomacy organized a symposium entitled "Role of Interfaith Dialogue in Building-Trust Among Intercultural Communities.

Great figures and famous personalities of academics, researchers, and intellectuals attended the event, including Prof. Aisha Al-Mannai, vice-chairperson of Doha International Center for Interfaith Dialogue and the Director of the Muhammad Bin Hamad Al Thani Center for Muslim Contribution to Civilization (CMCC) in College of Islamic Studies (CIS) at Hamad Bin Khalifa University's (HBKU), H.E Mr. Michael Schreuder, the acting deputy chief of Mission, at the embassy of the United States of America – Qatar.



Prof. Aisha Al-Mannai opened the event with a foreword she delivered. It contained a word of thanks to he audience, speakers, and the bodies collectively: organizing Doha International Center for Interfaith Dialogue, the Embassy of the United States of America, and the Cultural Village Foundation - Katara. She stressed the significance of the cooperative efforts that bring together the embassy of the USA in Qatar, Katara Public Diplomacy, and DICID, touching upon various forms of synergy among these institutions. She then shed the light on the interfaith dialogue as not only a necessary demand of the contemporary world but also as a very useful fruit of modernity in the research centers and among writers, due to its proven presence in cultivating people about the various relevant issues to coexistence and pluralism. She also added: "We all see and witness the great determinations DICID is doing towards realizing and achieving its objectives, it works hard to spread awareness on interfaith Dialogue among religious traditions with all possible means, instilling the culture of pluralism, and promoting acceptance of the others".

Followed by the foreword speech given by H.E Mr. Michael Schreuder the Acting Deputy Chief of Mission Embassy of the United States of America in Oatar delivered opening remarks of the United States of America in Qatar. He extended a word of thanks to Prof. AishaAl-Mannai, the moderator Ms. Marjon E Kamrani, the speakers, the audience, and all those who participated in making this event take place. Heexpressed that continuing to discuss relevant and various issues and topics of interfaith dialogue leads to many positive outcomes, including trust-building. He conveyed an important message that in interfaith dialogue communities are compelled to communicate and make their language understandable and acceptable.He stated: "Our goal in interreligious dialogue is not to construct one religion for the whole world but to share and learn from one another in celebration of our diversity and sharing the values we hold dear".

He also pointed out that interfaith dialogue should be characterized by clarity, trust, transparency, kindness, patience, generosity, and prudence. He thenmentioned in this regardthat in the United States of America, religious freedom lies at the heart of peoples' identity. He said: "The United States recognizes religious freedom as an inalienable right and it is therefore committed to its preservation and advancement for all". And he emphasized at the end of his remarks after he expressed special thanks to Prof. Ibrahim Al-Naimi for the great efforts he is doing, he emphasized the readiness of the embassy of the United States in Doha to proudly work and cooperate with Doha International Center for Interfaith Dialogue, to promote a culture of coexistence and tolerance.



Moreover, the event moderator Ms. Marjon E Kamrani, a political officer at the USA Embassy in Qatar highlighted the uniqueness and distinction of the event for many factors: the importance of the topic chosen for the symposium, the diversity of the themes to be discussed, as well as the academic variety among the distinguished speakers and the different background that should enrich the discussion.

Then she called upon Dr. Clyde Wilcox, Interim Dean, School of Foreign Service at Georgetown University in Qatar to deliver his paper entitled role of interfaith dialogue in contemporary relations. He commenced by saying: "This is my first interaction with the Doha International Center for Interfaith Dialogue, and I am honored to be a part of the panel". In his presentation, he highlighted the means of how individuals and societies should observe and maintainto enforce dialogue. interfaith Many personal experiences were provided to prove the validity of the points and to support the related ideas. He stated: "We know that friendly relationships - even friendships across religious lines reduces religious prejudice and hostility, and builds trust and tolerance".

He was followed by the second paper presenter Dr. Eid Ahmad Mohamed, Assistant Professor inComparative Literature Program at Doha Institute for Graduate Studies, who talked about Interfaith dialogue and awareness as tools to counter violent extremism. He expressed the importance of evoking the unity of the origin of mankind in facilitating communication, mutual respect, and then trust-building. "Bearing in mind human noble values that we all share paves ways to encounter prejudice, racism, and superiority claims. Commonalities and global ethics we all believe should be brought to promote tolerance, love, equality, mutual respect and coexistence". He supported the highlighted points he touched on by providing personal experiences as an Egyptian who lived, studied, and graduated from American universities and Canada.

Dr. Zachary Valentine Wright, Associate Professor at Northwestern University in Oatar was then invited to address Peace and reconciliation through interfaith dialogue. He stressed the importance of self-controlling and the so-called purification of one's soul in Islamic heritage (TAZKIYAH) in promoting dialogue and interfaith focusing on respecting the other and building trust in dealing with him/her. "Purification is a very useful tool in Islamic theology and thought for self-controlling. It also leads to perfection "IHSAN" and all will result in acceptance of the other". Many Qur'anic verses, Prophetic traditions, and Muslim Scholars' statements were quoted to support the discussion.

Before closing the event, the moderator Ms. Marjon then opened the Q & A session that enriched the discussion. Then she thanked the audience, speakers, all those who contributed by asking questions or giving comments and sent a special thanks to the three organizing bodies; Doha International Center for Interfaith Dialogue, the Embassy of the United States of America, and the Katara Public Diplomacy. She said: "After a long time of shifting this kind of event to virtual instead of physical because of the COVID 19 pandemic; I can see everywhere in the hall, before, after, and during the presentations smiles and happiness caused by physical interaction and meeting."I hope you have a good and safe drive home.



Doha International Center for Interfaith Dialogue participates in Cultural Symposium at the 31st Doha International Book Fair 2022



Within the activities of the Doha International Book Fair in its thirty-first session, under the slogan "Knowledge is Light", held under the supervision of the Ministry of Culture and the Qatar Cultural and Heritage Events Center, The Doha International Book Center organized a cultural symposium to discuss the book, "The Link between Religion and Science in the Light of the Noble Qur'an", hosting a discussion with the author of the book, Dr. Badrane Benlahcene, associate professor and researcher at the Ibn Khaldun Center for Humanities and Social Sciences, and Professor of comparative religion.

Dr. Ahmed Abdelrahim, senior researcher at the Doha International Center for Interfaith Dialogue, moderated the symposium. It was attended by a number of exhibition visitors, directors of publishing houses interested in issues of dialogue and religions, intellectuals, and a group of academics.

At the beginning of his speech, Dr. Badrane Benlahcene briefed the audience on his book; how the idea of writing it came to him, and the group to which the book was



directed to. He said: "All the chapters of this book revolve around one axis, which is religion and science in the light of the Holy Qur'an. It deals with the connection between religion (Islam) and science. It considers various issues of knowledge, thought, reading, reason and understanding, the integration of perceptual powers, the expansiveness of existence and the limitations of the conscience, the connection of knowledge with work, and other issues that we consider as gifts the Holy Qur'an provides us. The articles of the book aim at establishing a cultural awareness that transforms science to a culture that includes everyone, and a medium in which our values are formed about science and religion and the civilizational role they have, in the light of the integrative vision that the Qur'an establishes in the consciousness of the Muslim human being.

In the articles of this book, according to what he presented, the author has endeavored not to turn into an argument, justify positions, or provide academic lessons. His goal was an educational and informative goal, opening the minds of Muslim youth to the importance of these issues, and establishing a new awareness of the Qur'an, science and religion. It restores to the Muslim mind its cognitive and intellectual effectiveness, just as it restores to the Muslim person, individually and as a group, their effectiveness and complementarity.

The discussion on the book and its topics revolved around a dialogue between the moderator and the author, and many questions were raised about the issues presented in his book. The most important of which was the question about the broader concept of science as a subject and method, and the relationship between religion and science, as well as the extent to which the Western cognitive model in applied sciences and humanities makes the connection between Religion and science.

To this, Dr. Badrane Benlahcene, the author of the book, says: "Contemporary knowledge has made religion and science opposites, either a contradiction or that they are two isolated islands from each other, and this has led humanity to a kind of schizophrenia between religion, faith and science, and the Western cognitive model is basically a material model. According to it's scientific method, it rejects any source of knowledge outside the scope of physical sensory examination subject to experience and observation, and this strips man of his basic cognitive components, the first of which is religion, with which his instinct is raised, his psyche is balanced, his mind is purified, his conscience upright, and his spirit elevated."

He added: "The Holy Qur'an establishes (knowledge is not based on a single source, but rather it integrates sensory, mental and




spiritual perceptions, and the monotheistic vision that the Qur'an brought is based on a monotheistic conception in which human life is integrated, and his cognitive powers are integrated on knowledge of the truth".

Asking him about ways to restore a renaissance, as he always poses in his books and articles, Dr. Badrane Benlahcene said: "The Arab and Islamic nation today is experiencing a launch attempt to establish its civilizational cycle anew. In our lives, so that we do not fall into a distorted or contradictory reductionist understanding, especially with regard to

the relationship between religion and science."

It is worth noting that the Doha International Center for Interfaith Dialogue, which is the leading institution in Qatar concerned with interfaith and intercultural dialogue, participates - as it usually does every year - in the exhibition with its own stall where the center displays various publications of books specialized in dialogue in both Arabic and English, as well as its own Adyan journal, which is issued by the center periodically. So far, fifteen issues have been issued.





HBKU's College of Islamic Studies Welcomes DICID Chairman for Lecture on 'Coexistence in Qatar'


Dr. Ibrahim Saleh Al Naimi, Chairman of the Board of Directors of Doha International Center for Interfaith Dialogue (DICID), delivered a lecture titled "Coexistence in Qatar" at Hamad Bin Khalifa University's (HBKU) College of Islamic Studies (CIS). The lecture was attended by HBKU graduate students, faculty members, academic figures, and visitors with an interest in interfaith dialogue and peaceful coexistence.

The lecture is part of an important project on the Discourses of Hate, Tolerance and Co-existence led by Dr. Josef Meri, Historian of Interfaith Relations and the History of Religions at CIS, and engages an interdisciplinary team of scholars from across HBKU. It was delivered under CIS' joint cooperation agreement with DICID, as well as part of the intensive scientific efforts of Dr. Al-Nuaimi towards achieving the goals of DICID, promote awareness on interfaith dialogue, instill a culture of pluralism and acceptance of others, and share these issues scientifically and practically with graduate students, the Qatari community, and its scientific and cultural elites.

The event was opened by Dr. Meri, during which he highlighted the importance of this unique session. Dr. Aisha Al-Mannai, Director of the Muhammad Bin Hamad Al Thani Center for Muslim Contribution to Civilization (CMCC) at CIS, delivered opening remarks, and stressed the importance of the joint cooperation efforts that bring together CIS and DICID, touching upon forms of synergy between the two institutions. As part of the opening sessions, a short welcome clip was displayed by Mr. Dominic Genetti, the President and General Manager of ExxonMobil Qatar Ltd.

Dr. Al Naimi delivered his lecture, which began by thanking CIS and praising the efforts and achievements of Dr. Al-Mannai at DI-CID, CIS, and Qatar University's College of Sharia and Islamic Studies level in particular. The lecture focused on five key points, including the presentation of a brief overview on DICID, the role of the Qatari law in promoting peaceful coexistence, real models of such coexistence in the Qatari society, and the idea of establishing DICID based on a direction from the government to broaden the culture of peaceful coexistence. Dr. Al-Nuaimi concluded his lecture by highlighting DICID's key efforts intended to instill the culture of peaceful coexistence in Oatar.

"The vision of DICID aligns with Qatar's vision of dealing with all nationals and residents with respect for them and their religions, and allowing them to practice their religious rituals comfortably, without prejudice to the righteous teachings of the Islamic religion or the Qatari customs and traditions. A center like DICID in the Arabian Peninsula calling for dialogue and tolerance indicates globally how Islam is a religion of tolerance and love, and refutes all allegations on attaching Islam with terrorism or any other untrue accusations. DICID reflects Islam



as fully concerned with dialogue between followers of different religions, and provides them with an opportunity to coexist in Qatar as a safe, stable, and peaceful state that enables discussion of issues with followers of the other religions from different countries, and encourages tolerance and dialogue."

Since its establishment in 2007, DICID has undertaken its natural role in maintaining the appropriate settings for training Qatari and resident youth on issues of dialogue and bringing citizens and residents together regardless of their religions through community roundtables, which provide a platform for dialogue among communities, where they discuss issues of interest in various fields, including education, health, legal matters, and the cultural life in general. The center has also initiated a dialogue between them, the Qatari society, and official organizations so that their perspectives with regards to all issues are heard. This has been made possible through collaborations between the center and various institutions, including churches in Qatar.

Dr. Meri commented after the lecture: "CIS was honored to host HE Dr. Al-Nuaimi to speak on the importance of mutual and constructive co-existence and dialogue. While cultural, religious, and intellectual diversities bring with them a set of challenges, this has been an opportune way to engage faculty and students and deepen our understanding of the importance of strengthening social bonds. As well as instilling knowledge in our students, we also aim to equip them to become leaders and change-makers in a rapidly changing world."



The Police Department together

DICID, in collaboration with the Community Police Department, conducts a campaign to raise awareness of respect for religious and cultural diversity

In the context of promoting a culture of dialogue and peaceful coexistence between individuals and groups from different cultures and religions residing in Qatar, and in order to communicate and interact with the various groups in society, including groups of workers from different nationalities, and in order to consolidate participation between the police and society, the Police Department, in partnership with the Doha International Center for Interfaith Dialogue held an awareness campaign on respect for religious and cultural diversity at the residence of Qatari Diar employees and workers (QD-SBG), on Sunday evening, April 10, 2022.

The administration's key goals for its annual plan for 2022 is to reduce crime rates by raising awareness of the dangers of theft crimes and raising awareness of the importance of respecting religions and cultures.

He pointed out that the awareness campaign began with a visit to the headquarters of Qatar Diar, focusing on a number of axes, foremost of which is respect for customs and traditions, and awareness of theft crimes in the residential areas of workers, adding that the campaign will continue throughout the holy month to include a number of regions in the country.

He also stressed that such awareness campaigns intersect their objectives with Qatari efforts to promote coexistence and peace, and contribute to highlighting the value of tolerance, compassion and compassion in Qatar, which is a country of peace and tolerance for its citizens and residents despite the various nationalities and religions.

It is worth noting that the Doha International Center for Interfaith Dialogue pays great and real attention to the conditions of the communities residing in Qatar, as these communities have an important role in consolidating the values of peaceful coexistence and tolerance between the communities on the one hand, and with the Qatari society on the other hand and accordingly, since its establishment, cooperation with local communities has been a top priority for the center."

participates in the Eighth Meeting of the United Nations Istanbul Process



His Excellency Dr. Ibrahim bin Saleh Al Naimi, Chairman of the Board of Directors of Doha International Center for Interfaith Dialogue, participated in the Eighth Meeting of the United Nations Istanbul Process, which was held on Wednesday 16 February 2022 by the Permanent Mission of Pakistan to the United Nations and the Islamic Republic of Pakistan on the occasion of the 10th anniversary of the landmark UN Human Rights Council (HRC) resolution 16/18 on "Combating Intolerance, Negative Stereotyping and Stigmatization of, and Discrimination, Incitement to Violence and Violence Against Persons Based on Religion or Belief" adopted in 2011.



Dr. Al-Naimi was invited as speaker as the Chairman of the Doha International Center for Interfaith Dialogue representing the State of Oatar, to mention the activities and landmark efforts in progressing interfaith harmony and combating religious hatred. He highlighted the urgent need for the active implementation of the Istanbul Process Action Plan given the instability of religious communities over the past few years caused by the increasing global spread of hate speech, intolerance, racism, nationalism and religious extremism, which has collectively hampered progress towards international cooperation. He stated, "... religion needs to be exonerated and differentiated. It should be part of the peacemaking process instead. And it lies in our hands to see it in action". In his speech, he also touched on the Center's activities which includes the annual International Conference on Interfaith Dialogue the most recent of which is upcoming in Doha on the 24th and 25th of May 2022 entitled, "Religions and Hate Speech: Between Scripture and Practice".

The Center also holds round tables that discuss issues related to communities in Qatar. At the local level, the Center regularly organizes training courses for students and teachers in independent and private schools with the aim of training on dialogue and communication skills with different religions and cultures, in addition to issuing the "Adyan/Religions" journal in Arabic and English, periodical newsletters, translated books, and selected letters, and publications related to the center's activities. On the international level, Dr. Al-Naimi mentioned that the center has numerous symposia and international conferences outside Qatar focused on promoting a culture of dialogue and peaceful coexistence.

It is worth noting that the Istanbul Process focuses on concrete, positive measures that

states can take to combat religious intolerance while protecting the freedoms of religion and free speech. The Eighth Meeting as such was themed as 'Looking Back and Moving Forward' and was attended by around 200 high-level representatives of States, intergovernmental organizations, civil society, faith and community leaders.

The conference was inaugurated by His Excellency Shah Mahmood Qureshi, the Foreign Minister of Pakistan. In his speech, he presented a preventive and action-oriented strategy to counter religious hatred and especially islamophobia, which has been on an alarming rise in recent years. The Foreign Minister of Turkey, His Excellency Mevlüt Cavuşoğlu also addressed the meeting along with the OIC Secretary General H.E. Hissein Brahim Taha, the UK Minister of State for the UN H.E. Lord Ahmad of Wimbledon, the US Under Secretary of State for Civilian Security, Democracy, and Human Rights at the U.S. Department of State H.E. Uzra Zeya, the President of the UN Human Rights Council, the UN Deputy High Commissioner for Human Rights, the High Representative for UN Alliance of Civilizations and the former OIC Secretary General Professor Ekmeleddin Ihsanoglu.

The agenda of this year's meeting discussed the world's most pressing concerns over growing hate and conflict directed towards religious communities and presented initiatives and success stories along with their case studies that has since enabled communities to effect positive change in combatting hatred and hate speech, ten years after the 16/18 resolution. The State of Qatar represented in the Doha International Center for Interfaith Dialogue is committed to bringing about a culture of peace, tolerance and inter-faith harmony and continues to take steps for its achievement.

Under the auspices and in the presence of the President of the State of Kazakhstan, Mr. Qasim Jomart Tokayev, Kazakhstan hosted the seventh session of the Conference of Leaders of World and Traditional Religions in the capital Nur-Sultan on September 14-

15, in the presence of the Grand Imam, Dr. Ahmed Al-Tayeb, Sheikh of Al-Azhar Al-Sharif, and His Holiness Pope Francis, Pope of the Vatican and participation of major religious leaders from around the world, as well as 100 delegations from 60 countries representing all religions. The conference was titled "The Role of Leaders of World and Traditional Religions in the Spiritual and Social Development of Humanity in the Post-Pandemic Era" Among them was the delegation of the State of Qatar led by Mr. Khalid bin Shaheen Al-Ghanim, Director of the .Department of Islamic Affairs at the Ministry of Awqaf

Doha International Center for interfaith Dialogue in Qatar (DICID) participates in the International Ministerial Conference on Freedom of Religion or Belief (FoRB) for All in London

The International Ministerial Conference on Freedom of Religion or Belief (FoRB) for All began on Tuesday morning July 5 at the Queen Elizabeth II Conference Centre (QEIICC) in London. The conference is taking place for two days, July 5 and 6, 2022, and is hosted by the UK government. The event builds on previous Ministerial-level conferences held by the United States in 2018 and 2019 and in virtual format by Poland in 2020.

The ceremony began with an opening speech by Charles, Prince of Wales, heir apparent to the British throne (via video), followed by a speech by Boris Johnson, Prime Minister of the United Kingdom (via video). This was followed by the speech of Lord Ahmed, who is responsible for organizing the conference. Many other notable figures spoke at the opening ceremony, including the Archbishop of Canterbury, Justin Welby, Sheikh Mohammed Al-Issa, Secretary General of the Muslim World League, a number of representatives of various religions, and the British Foreign Secretary Mary Elizabeth Truss (Liz Truss).



All speakers at the opening ceremony emphasized religious freedom and the need to exercise it at all levels. The delegations of the State of Qatar at the conference Ministerial Conference on are His Excellency Prof. Ibrahim Al-Naimi. Chairman of DICID, and Mr. Mohammed Al-Jabir Deputy Head of Mission at the Embassy of the State of Qatar in London.

The event calls for strengthened

global action on Freedom of Religion or Belief (FoRB) for all. Speaking about the importance of attending the conference, Prof. Ibrahim said, "It is necessary for DICID to be part of this global gathering together governments, that brings parliamentarians. faith and belief representatives, and civil society to push for strengthened global action on freedom of religion or belief for all. For DICID has proven to the world the great role that the State of Qatar, represented in DICID, plays in spreading the culture of religious freedom."

gives a presentation at a regional conference on "The Role of Religious Leaders and Actors in Combating Hate Speech

Within the framework of the international participation of Doha International Center for Interfaith Dialogue in everything related to spreading the culture of dialogue and strengthening the role of the State of Qatar in combating hate speech and supporting all efforts aimed at enhancing the value of world peace, and at the invitation of the Office of the UN Human Rights Regional Office for the Middle East and North Africa (ROMENA) located in Lebanon, His Excellency Prof. Ibrahim bin Saleh AlNaimi, Chairman of the Board of Directors of Doha International Center for Interfaith Dialogue, delivered a keynote address at the regional conference on "The Role of Religious Leaders and Actors in Combating Hate Speech," held on Thursday, September 1, 2022.

The paper His Excellency delivered at the fourth session of the conference dealt with "Initiatives to Combat Hate Speech in the Arab Region" and was entitled: "The Initiatives of the State of Qatar and Doha **International Center for Interfaith Dialogue** to Combat Hate Speech"; the paper addressed relevant initiatives in line with the "Fez Process," where the "Fez Process" refers to a series of consultations organized by the United Nations Office for the Prevention Genocide and the of Responsibility to Protect between April 2015 and December 2016 with religious faith-based leaders, and secular organizations, regional organizations, and

experts from all regions of the world. The recommendations contained in the Action Plan were developed by the religious leaders and stakeholders who participated in these consultations.

Prof. Al-Naimi began his presentation with an introduction on the importance of the role of religious leaders and actors in combating hate speech, and then went into detail about the initiatives of the State of Qatar to combat hate speech, followed by the efforts and initiatives of Doha International Center for Interfaith Dialogue in the same framework.

The paper concluded with a series of suggestions and recommendations for developing the role of religious institutions in combating hate speech, including: "Religious institutions must open up to the various institutions of society and cooperate with each other to spread a culture of tolerance, moderation and coexistence. Organizing conferences, seminars, workshops, and training courses in schools, universities, and youth meeting centers, and setting up youth camps or round tables involving academics, religious scholars, and influential figures in society and among the youth. And more attention to education about Dialogue, diversity, differences and coexistence.

His Excellency stressed the importance of continuing to hold such conferences through which "we can create a network of effective

relationships and partnerships aimed at crystallizing a common vision for collective action in promoting the values of tolerance, combating hatred and spreading a culture of peace in our societies, especially those that have suffered the scourge of various conflicts, so that they can return to the path of development and reconstruction.

It is worth noting that this conference took place in the framework of the Advocacy Week, with the participation of several parties and numerous activities organized by the Office of the United Nations High Commissioner for Human Rights with its partners, to raise awareness and stimulate Dialogue on dealing with hate speech and promoting a culture of peaceful and effective social Dialogue on the role of religious leaders and actors in preventing the spread of hatred and combating incitement to it, by bringing together leaders and representatives of various actors in the Arab region to share experiences and knowledge among themselves. The conference will address the progress made in efforts by religious leaders and actors in the Arab region to combat hate speech and promote tolerance and respect for diversity.

Doha International Center for Interfaith Dialogue signed four memoranda of understanding with international institutions under the title (Religions and Hate Speech...Between Practice and Scriptures) at the closing ceremony of the



14th Doha Conference on Interfaith Dialog held in Doha on May 24-25, 2022.

DICID recognizes that a variety of these institutions in different countries are necessary to achieve DICID's goals of expanding its relationships and building bridges of cooperation and understanding among adherents of religions, cultures, and civilizations throughout the world, building capacity in the area of dialogue, the culture of peace, and acceptance of others, and activating religious values to address issues and problems that affect humanity and to address aspects of life's interaction with religion.

The first of these institutions to sign a memorandum of understanding was a European institution, the Muslim League in the Republic

of Poland, represented by Dr. Abdul-Jabbar Ahmad al-Kubaisi, the Secretary General of the Islamic Association and Director of the Warsaw Center. He works in solidarity with other Islamic centers to achieve common goals by conducting various visits, delivering lectures in schools and universities, and participating in various events and conferences.

The second institution came from Africa, namely from the Republic of Mali. DICID signed a memorandum of understanding with the Per-





manent Secretariat for Countering Extremism and Terrorism, represented by Mr. Jobero Diallo, the Secretary-General. This is an institution specialized in national policy to prevent and counter extremism and terrorism, attached to the General Secretariat of the Ministry of Religious Affairs and Customs. It is also tasked with ensuring the technical coordination of the Lead Committee and the Coordination Committee and evaluating the national policy on preventing and countering extremism and terrorism.

Another memorandum of understanding was signed with a third institution from the Republic of Kazakhstan, the Nazarbayev Center for the Development of Dialogue between Religions and Civilizations, represented by the Chairman of the Board of Directors, Bulat Sarsenbayev. It is an international institution established by the first President of the Republic of Kazakhstan, Nursultan Nazarbayev, with the aim of seeking common points of convergence and humanitarian milestones between religions and cultures for peace.

At the closing ceremony of the 14th Doha Conference on Interfaith Dialogue in May 2022, DICID also signed the fourth Memorandum of Understanding with an academic scientific institution in the United States of America, Brigham Young University. It is a non-profit institution engaged in higher education. It is a private research college located in Provo, Utah, USA. It was founded in 1875 by religious leader Brigham Young and is sponsored by The Church of Jesus Christ of Latter-day Saints (LDS Church). Its goal is to strengthen the spiritual aspect of education, expand the intellectual realm of education, and build a human personality that leads to lifelong learning and service.

These Memoranda of Understanding are based on the intention of both parties to achieve their common goals and to exchange benefits and experiences in the field of scientific and academic expertise; considering that Doha International Center for Interfaith Dialogue in the State of Qatar is an international center that strives to spread the culture of interfaith dialogue.






